Objectives and Investment Policy

Objective: The Sub-Fund aims to maximise the total level of return for investors by investing, mainly, in a diversified portfolio of bonds and other similar debt securities.

Investment Policy: The Investment Manager (“We”) will primarily invest in Emerging Market Corporate fixed income securities and Emerging Market Government fixed income securities with maturities of 10 years or less. We aim to construct a diversified portfolio for the Sub-Fund with fixed income securities with an average credit quality of “B3” by Moody’s or “B-” by S&P, although individual bond holdings may have higher or lower ratings. The Investment Manager may also invest up to 15% of the Net Assets of the Sub-Fund in Emerging Market equities. The Investment Manager may invest in all of these asset classes either directly or indirectly through UCITS Funds and/or eligible non UCITS Funds.

The Sub-Fund will hold a diversified portfolio of investments over a broad base of issuers and industries, will not be targeting debt securities of any particular duration and/or coupon, but will focus primarily on Emerging Market issuers.

We consider various factors when choosing which fixed income securities to invest in, including: (i) yields; (ii) issuer specific variables; (iii) terms of issue of the securities; (iv) the experience and track record of the issuer’s management; (v) the spread at which a bond issuer is trading and (vi) market-technical factors. Generally, the bonds that we aim to buy are Emerging Market Corporate Bonds and Emerging Market Government Bonds with ratings of between “Baa1” to “Caa1” by Moody’s or “BBB+” to “CCC+” by S&P or in bonds determined to be of comparable quality, subject to investing up to 10% in unrated bonds. Furthermore, we will not be investing in unlisted Transferable Securities and unlisted Money Market Instruments.

In pursuing its Investment Objective and Investment Policy, the Sub-

Fund will be subject to the Investment, Borrowing and Leverage Restrictions set out in the Prospectus and the Offering Supplement.

Management Discretion: The Investment Manager has the discretion to buy and sell investments on behalf of the Sub Fund within the limits of the Objective and Investment Policy.

Currency: The Shares in the Sub-Fund are denominated in USD.

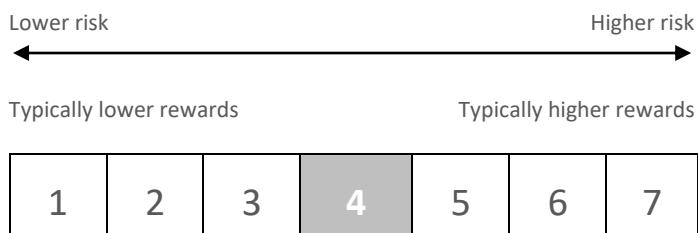
Buying and Selling Shares: You can buy and sell Class B - USD (Distribution) Investor Shares (this “Class”) each business day (Monday to Friday other than public holidays in Malta).

Distribution Policy: This Class is a distributor class so the income from investments held for the Class will be paid out as dividends rather than re-invested. The Company aims to declare dividends on the 31st March and 30th September each year.

Long-term investment: You should consider Shares in the Sub-Fund as a long-term investment. Since Entry Charges (see below) are deducted from your subscription amount, if you sell your Shares before the price of the Shares increases, you may receive less than the amount invested.

Recommendation: This Sub-Fund may not be appropriate for investors who plan to withdraw their money within less than 3 years.

Risk & Reward Profile
