TERM	• This product has no maturity date.	
	• The Sub-Fund aims to achieve a higher level of return for investors by investing, mainly, in a diversified portfolio of bonds and other similar debt securities.	
OBJECTIVE	• The Investment Manager ("We") will primarily invest in corporate and government bonds maturing in the medium term (10 years maturity or less). We aim to construct a diversified portfolio for the Sub-Fund mainly composed of high yield bonds with an average credit quality of "Ba3" by Moody's or "BB-" by S&P, although individual bond holdings may have higher or lower ratings. Generally, the bonds that we aim to buy are high yield (below investment grade) bonds with ratings of between "Baa1" and "Caa1" by Moody's or "BBB+" to "CCC+" by S&P or be of comparable quality, subject to investing up to 10% in unrated bonds.	
	 the Sub-Fund shall be precluded from investing, in the aggregate, more than 10 % of its assets in units or shares of other UCITS or other CIS. We may use financial derivative instruments such as options, futures and forwards for hedging purposes but not for speculative purposes. The Fund is actively managed, not managed by reference to any index.

Management Discretion: The Investment Manager has the discretion to buy and sell investments on behalf of the Sub-Fund within the limits of the Objective and Investment Policy.

Currency: The Shares in the Sub-Fund are denominated in Euro.

Buying and Selling Shares: You can buy and sell this "Class" on each business day (Monday to Friday other than public holidays in Malta and the Dividend Cut-Off Date, as defined in the Offering Supplement of the Sub-Fund). The Investor has the right to exchange his investment in units and related Offering Supplement as well as the latest annual and halfin one compartment for units in another compartment.

Distribution Policy: This Class is a distribution class so the income from frequency as may be determined by the Directors in accordance with the can be obtained from the Offering supplement available on Prospectus

Target: the fund doesn't target any particular industrial, geographic or other market sectors. The fund invests predominantly in high yield corporate bonds.

Long-term investment: You should consider Shares in the Sub-Fund as a long-term investment. Since Entry Charges (see below) are deducted from your subscription amount, if you sell your Shares before the price of the Shares increases / dividends are paid you may receive less than the amount invested.

The Sub-Fund's depositary bank is Sparkasse Bank Malta plc. The Sub-Fund's assets and liabilities as well as its legal liability are segregated from other Sub-Funds of the Company.

WHAT HAPPENS IF CALAMATTA CUSCHIERI INVESTMENT MANAGEMENT LIMITED IS UNABLE TO PAY OUT?

Recommended holding period: 5 years

You should be prepared to remain invested in the fund for at least 5 years. Redeeming earlier can result adversely impact the return you get from investing in this product.
