WHAT IS THIS PRODUCT?

OBJECTIVES	<ul style="list-style-type: none">The Sub-Fund aims to deliver a positive total return in any three year period from a flexibly managed portfolio of global assets. The Investment Manager will invest in a flexibly managed portfolio of assets invested around the world, with the aim of delivering a positive total return whilst maintaining a monthly VaR with a 99% confidence interval at or below 5% at all times.The Investment Manager shall invest primarily in a diversified portfolio across a wide spectrum of industries and sectors primarily via bonds, equities and eligible ETFs. The Investment Manager may invest in these asset classes either directly or indirectly through UCITS Funds and/ or eligible non UCITS Funds.The Investment Manager may invest in both investment grade (corporate and sovereign) and high yield bonds that have a credit rating of at least "B-" by S&P (or rating equivalent issued by other reputable rating agencies) at the time of investment, provided that the Sub-Fund may invest a maximum of 10% of its assets in non-rated debt securities, including those listed on the Malta Stock ExchangeWe may use financial derivative instruments such as options, futures and forwards for hedging purposes but not for speculative purposes. WHAT HAPPENS IF CALAMATTA CUSCHIERI INVESTMENT MANAGEMENT LIMITED IS UNABLE TO PAY OUT?

By law, the fund's assets may not be held in custody by the fund management company. Instead, each fund must have a specific depository that handles the safekeeping of the fund's assets. In the event of the bankruptcy of the fund management company, the management of the fund is taken over by the depository (Sparkasse Bank Malta plc). There is no compensation or guarantee scheme for investors in the fund.

WHAT ARE THE COSTS?

Cost over time
