WHAT IS THIS PRODUCT?

OBJECTIVES	 The Investment Objective of the Fund is to seek to achieve a steady positive return with relative low volatility and limited correlation to market cycles affecting traditional fixed income and equity markets. 			
	 The Investment Manager shall invest with a global approach in transferable securities (i.e., fixed income, bonds and equities listed or admitted to trading on a regulated market) and money market instruments that are well diversified from a geographic industrial sector and currency point of view.

- The Sub-Fund shall not invest more than 10% of its net asset value in units or shares of UCITS (including for the avoidance of any doubt other sub-funds of the Company) and/or other eligible non-UCITS.
- The Sub-Fund shall not invest more than: (i) 20% of its net assets in non-investment grade bonds (including high-yield bonds); 40% of its net assets in equities; (iii) 40% of its net assets directly or indirectly in emerging countries and if the Sub-Fund invests in emerging countries, it will focus mainly on Latin America and Asia (including but not limited to South Korea, the People's Republic of China, Hong Kong, Taiwan, Japan, India, Indonesia, Vietnam, Thailand, Philippines, Malaysia, Australia, New Zealand and Singapore).
- The Sub-Fund shall not invest in contingent convertible bonds, asset backed securities, mortgage-backed securities, structured products or distressed securities.
- We may use financial derivative instruments such as options, futures and forwards for hedging purposes but not for speculative purposes. Other than in relation to these hedging instruments, the Sub-Fund will not be leveraged.

The Fund is actively managed, not managed by reference to any index.

Management Discretion: The Investment Manager has the discretion to buy and sell investments on behalf of the Sub-Fund within the limits of the Objective and Investment Policy.

Currency: The Shares in the Sub-Fund are denominated in

Buying and Selling Shares: You can buy and sell Class A the Dividend Cut-Off Date, as defined in the Offering Supplement of the Sub-Fund). The Investor has the right to exchange his investment in units in one compartment for units in another compartment.

Distribution Policy: This Class is an accumulator class so the income from investments held for the Class will not be paid out as dividends. Instead, income will be re-invested and reflected in the value of the Shares.

Target: the fund doesn't target any particular industrial, geographic or other market sectors.

Long-term investment: You should consider Shares in the Sub-Fund as a long-term investment. Since Entry Charges (see below) are deducted from your subscription amount, if you sell your Shares before the price of the Shares increases / dividends are paid you may receive less than the amount invested.

The Sub-Fund's depositary bank is Sparkasse Bank Malta plc. The Sub-Fund's assets and liabilities as well as its legal liability are segregated from other Sub-Funds of the Company.

WHAT HAPPENS IF CALAMATTA CUSCHIERI INVESTMENT MANAGEMENT LIMITED IS UNABLE TO PAY OUT?

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 3 years
