WHAT IS THIS PRODUCT?

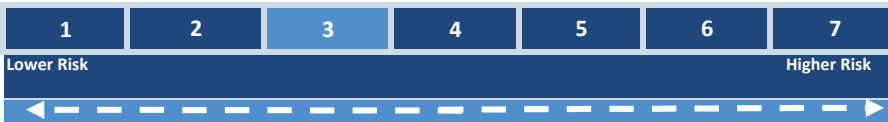

OBJECTIVES	<ul style="list-style-type: none">The Sub-Fund aims to deliver a positive total return in any three year period from a flexibly managed portfolio of global assets. The Investment Manager will invest in a flexibly managed portfolio of assets invested around the world, with the aim of delivering a positive total return whilst maintaining a monthly VaR with a 99% confidence interval at or below 5% at all times.The Investment Manager shall invest primarily in a diversified portfolio across a wide spectrum of industries and sectors primarily via bonds, equities and eligible ETFs. The Investment Manager may invest in these asset classes either directly or indirectly through UCITS Funds and/or eligible non UCITS Funds.The Investment Manager may invest in both investment grade (corporate and sovereign) and high yield bonds that have a credit rating of at least "B-" by S&P (or rating equivalent issued by other reputable rating agencies) at the time of investment, provided that the Sub-Fund may invest a maximum of 10% of its assets in non-rated debt securities, including those listed on the Malta Stock ExchangeWe may use financial derivative instruments such as options, futures and forwards for hedging purposes but not for speculative purposes. WHAT HAPPENS IF CALAMATTA CUSCHIERI INVESTMENT MANAGEMENT LIMITED IS UNABLE TO PAY OUT?

By law, the fund's assets are not held in custody by the fund management company and each fund must have a specific depositary that handles the safekeeping of the fund's assets. The fund's assets and liabilities are segregated from the assets and liabilities of other sub-funds and of the investment manager. As a result, the fund's ability to pay out is not affected by the default of Calamatta Cuschieri Investment Management Ltd. In the event of the bankruptcy of the fund management company, the management of the fund is taken over by the depositary (Sparkasse Bank Malta plc). There is no compensation or guarantee scheme for investors in the fund.

WHAT ARE THE COSTS?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does where applicable. Recommended holding period: 3 years

The fund has no minimum holding period requirement but it is suitable for a medium to long investment horizon. You should be prepared to save in the fund for at least 3 years. Redeeming earlier can result adversely impact the return you get from investing in this product.

You can buy and sell the fund the third Business Day of every calendar week without any additional fee.
